OPERATOR TRAINING

POWERED INDUSTRIAL TRUCK TRAINING I

Class Length: 1/2 Day
Max # of Participants: 20

The Powered Industrial Truck Training (PITT) is a classroom-only course that teaches safe and effective operation of powered industrial trucks (forklifts). This course covers safety principles, regulations, pre-operation inspections, load handling and hazard identification. Students learn about different truck types, their capabilities and limitations, emphasizing the importance of balance and stability, speed and braking techniques, and proper loading and unloading procedures. Certification is not provided.

FALL ARREST & FALL PROTECTION

Class Length: 1/2 Day
Max # of Participants: 20

This course covers OSHA fall protection standards for construction and general industry. It provides an overview of fall protection methods. Topics include principles, components, limitations of fall arrest and the OSHA standards regarding fall protection. Upon completion of this course, students will have knowledge of the OSHA fall protection standards and implement fall protection plans.

MEWPs

Class Length: 1 day
Max # of Participants: 8

The Mobile Elevated Work Platform (MEWP) operator training course covers classroom instruction, hands-on training and evaluation to ensure safe and effective operation. Students are evaluated operating a MEWP and must pass a written exam to complete the course. Successful completion earns the student an operator card and a compliance certificate with OSHA and ANSI standards.

RAILCAR MOVERS

Class Length: 1 day
Max # of Participants: 8

This course trains students to become certified railcar movers through classroom and hands-on instruction. Topics include safety principles, guidelines, train-air system requirements and machine capacity. Students complete a pre-operation inspection and a workplace evaluation operating with and without a load. Upon meeting all course requirements, students receive an operator's certificate from LiftOne on behalf of their employer.

POWERED INDUSTRIAL TRUCK TRAINING II

Class Length: 1 day
Max # of Evaluations: 15

Powered Industrial Truck Training (PITT) II is the next step towards earning an operator certification following the PITT I classroom portion. This course offers hands-on experience under an experienced instructor's supervision. Students are evaluated in the workplace after taking time to practice. LiftOne issues the certification on behalf of the student's employer once the course is successfully completed. This certification meets OSHA requirements.

TRAILER SPOTTERS

Class Length: 1 day
Max # of Participants: 8

This training provides a turn-key solution to certify operators, with classroom instruction, hands-on training and evaluation. Students learn about regulations, safety principles, pre-operation inspection criteria and safe load manipulation. After a hands-on inspection, students practice with a trailer spotter and complete a practical evaluation in the workplace. Successful completion earns a certification compliant with OSHA regulations.

TELEHANDLERS

Class Length: 1 day
Max # of Participants: 8

This course offers comprehensive learning experience on safety protocols, operational techniques and maintenance procedures for telescopic handlers. Participants will engage in in-depth classroom instruction, written examination and practical evaluation to demonstrate their abilities to operate telescopic handlers safely and effectively. Upon completion of this course, students will have knowledge and certification in compliance with OSHA standards for telescopic handlers.

SKID STEERS

Class Length: 1 day
Max # of Participants: 8

This course offers comprehensive learning experience on safety protocols, operational techniques and maintenance procedures for skid steer loaders. Participants will engage in in-depth classroom instruction, written examination and practical evaluation to demonstrate their abilities to operate skid steers safely and effectively. Upon completion of this course, students will have knowledge and certification in compliance with OSHA standards for skid steers.

TRAIN-THE-TRAINER TRAINING

FORKLIFTS

Class Length: 2 days
Max # of Participants: 10

Experienced operators can become effective trainers through this classroom-only course. Topics covered include regulations and guidelines, pre-operation inspections, load handling and hazard identification. Upon successful completion, new trainers will be equipped to lead training for your operations, with necessary materials provided.

TRAILER SPOTTERS

Class Length: 1 day
Max # of Participants: 6

This course trains operators on trailer spotter regulations, guidelines, safety principles and best practices through classroom and hands-on instruction. Students follow experienced instructors in pre-shift inspections, recommendations for evaluations and assess their peers operating in a simulated environment. Upon completion with all required training materials, graduates are qualified to teach and evaluate trainees.

MEWPs

Class Length: 1 day
Max # of Participants: 6

The Mobile Elevated Work Platform (MEWPs) course provides future trainers the knowledge and skills necessary to effectively train students on how to operate a MEWP safely and competently. The course includes theoretical instruction and practical training, helping trainers understand MEWP safety principles and how to effectively communicate to their trainees. After completing the course, trainers receive their own operator certification and the necessary materials to lead future classes.

RAILCAR MOVER

Class Length: 1 day
Max # of Participants: 6

This course teaches your trainers to understand railcar mover fundamentals, regulations, safe operations and proper handling techniques. Students start in the classroom, then move to a hands-on setting to learn pre-operation inspections, train air configuration and coupling. The class ends with peer evaluations. Once successfully finished, LiftOne will provide all training materials to deploy this class.
